Overview

Research now confirms that billionaire-backed foundations, including those headed by Michael Bloomberg and Bill Gates, are actively interfering in the Asia-Pacific region much more than once thought.

Dismissing compelling international scientific evidence, they're applying bullying tactics to unduly influence sovereign nations' public health policies.

While many independent Asia-Pacific countries are delivering progressive and successful tobacco harm reduction policies and programs, big money and influence – mostly American - are conspiring to demonize their work.

Vaping is now the most effective smoking cessation tool in the world. However, a handful of billionaire-related charitable organizations and pharmaceutical companies are spending hundreds of millions of US dollars to force an anti-vaping agenda onto unsuspecting countries.

The billionaires are tied to the charities, the charities are tied to the pharmaceuticals, and the pharmaceuticals are tied to the billionaires. Most alarmingly, they don't reveal these ties as money changes hands and their talking points are unwittingly parroted out of the mouths of government officials.

Talking points, repeated countless times, squeeze out consensus evidence and those with opposing viewpoints are in many cases publicly bullied into submission.

Perverting countries' democratically elected political systems, this small, corrupt network of elites sweep in and influence. Funneling cash through a myriad of anti-tobacco organizations and charities, they're particularly focused on influencing laws in more vulnerable developing countries.

The corruption and conflicts of interest are blatant. For example, big pharma is using their charitable organizations to attack vaping while marketing their own smoking cessation products.

Citizens' rights are being bulldozed and national freedoms are being harmed – all in the paternalistic pursuit of pushing policies onto others which end up negatively impacting local people's health and lives.

In recent years, stories of undue influence involving billionaire-backed foundations have been gaining traction.

This research finally reveals some crystal-clear evidence as to what exactly is going on: Bloomberg and Gates are now heavily involved across the Asia-Pacific region.

The first item listed on Mohamed's resume is a certificate from Johns Hopkins University in "Global Tobacco Control." This is the Institute For Global Tobacco Control, at the Bloomberg School of Public Health at Johns Hopkins. Mr. Bloomberg has donated over US \$3 Billion to the university, and it is closely tied to the Bloomberg anti-tobacco initiative. In addition, the Institute works closely with the WHO.





The Institute exists to promote anti-tobacco legislation abroad, and its head has plainly stated, "Vaping is not safe." For Mr. Mohamed to have this certificate listed first on his CV indicates that he has clearly adopted their anti-vaping posture as his own, and cannot be considered a neutral party. Whatever he publishes can be seen as skewed by the indoctrination of the Bloomberg anti-tobacco team.

The United States Internal Revenue Service (I.R.S.) requires that public foundations file an annual Form 990 which broadly outlines an organization's income and spending. The information requested is not terribly detailed, and so specific grant details are not usually available. Bloomberg will list millions of dollars in grants to The Union, for example, but will not list all of the specific programs that those grants are funding.

We were able to look at Bloomberg Philanthropies' U.S. tax filings for the period of 2011 to 2017. More recent filings are not yet publicly available. Of note – 2014 information is unavailable as the public filing does not include any grantmaking specifics.

Below you will see over \$449 million dollars in grants from Bloomberg to anti-tobacco groups. Later in the document, we look at how these groups are working to push the Bloomberg agenda throughout the Asia-Pacific region.
